- 3. The Proposed Budget for Fiscal Year 2024 as approved by the Council of Trustees.

#### PROPOSED AMENDMENT TO THE CONSTIUTION FEBRUARY 18, 2024

The proposed amendment to the constitution for Article XII is to bring alignment with our Bylaws. We currently have a contradiction as it relates to how our property is titled. Our current title is in the name of the corporation and not in the name of the Trustees. This amendment will correct this contradiction.

#### CURRENTLY STATED IN THE CONSTITUTION:

ARTICLE XII – PROPERTY (Realty)

Section 2 The title for real property shall be vested in "Trustees of Grace World Outreach Church," and to their successors in office. An approved abstract or title insurance policy will be required. For purposes of definition, "Trustees" shall mean the current members of the Council of Trustees.

#### PROPOSED AMENDED TO READ:

#### ARTICLE XII – PROPERTY (Realty)

Section 2 All property, real or chattel, shall be taken, held, sold, transferred, or conveyed in the corporate name of the Assembly, or if the Assembly is not incorporated, by the Trustees and their successors in office. For purposes of definition, "Trustees" shall mean the current members of the Council of Trustees.

#### **CURRENTLY STATED IN BYLAWS:**

#### ARTICLE VI - PROPERTY RIGHTS

Section 1 *All property, real or chattel, shall be taken, held, sold, transferred, or conveyed in the corporate name of the Assembly, or if the Assembly is not incorporated, by the Trustees and their successors in office.*

#### GRACE LEADERSHIP ACADEMY

Grace Leadership Academy (GLA) is a K-12 private school that is registered with the Department of Education and operates as a ministry of Grace World Outreach Church. The Chief Administrative Officer is the Lead Pastor at Grace World, and the governing board is the Board of Trustees. All staff and faculty are Grace World Outreach Church employees.
